Conditions of Purchase and Use of the 'Money-4-Nothing' System Pack

Failure to seek reimbursement for return of the sealed pack within 60 days of receipt will be deemed as full acceptance of the following conditions.

In the following conditions the 'seller' will be 'Intelligent Opportunities'

- 1.
